#### Attendance

Attendance at school is now again mandatory. We have started back at school with attendance between 97 and 98% which is really fantastic! We do though need to share the following reminders with you all:

# **Holidays in Term Time**

Government legislation states that only under exceptional circumstances may the Head teacher consider giving permission for a child to be absent from school at any point in the academic year. Under the legislation parents have no entitlement to take their child out of school for a holiday in term-time.

This can lead to Penalty Notices - See below.

# Penalty Notices for Non- school attendance

Section 444(A) of the Education Act 1996 empowers the local authority to issue Penalty Notices in cases of unauthorised absence from school. This means that when a pupil has unauthorised absences of 10 sessions (5 days) or more, in a 12-week period (where no acceptable reason has been given for the absence) or if their child persistently arrives late for school after the close of registration, their parents may receive a Penalty Notice of £120, which is reduced to £60 if paid within 21 days. The Penalty Notice will need to be paid in full before 28 days of the notice being served. Failure to pay a penalty notice may result in prosecution (a separate penalty notice will be issued to each parent for each child).

## **Covid Symptoms**

If anyone in your household (and support or childcare bubble) is displaying any of the main Covid symptoms, then all members of the household (and anyone in your support or childcare bubble) needs to stay at home and isolate.

## Your child must not attend school in these circumstances.

The individual with symptoms needs to book a test. Please inform us of the results when you have them.

Please email school <u>admin@cdatstpaulsprimary.co.uk</u> and leave the following information and also phone the school:

- The name of your child (who has tested positive and attends St Paul's CE Primary)
- Name of their class and class teacher
- Date when your child was last in school
- Symptoms that were being displayed and the date they started
- The date the test was taken
- The date of the positive test

By doing this we all reduce the risk of transmission and the need to have to inform wider groups of people of the need to self-isolate.

If we have to inform you of a positive case in the school community and advise that your child would need to self-isolate, then we would do this through the school spider email system.
